## Notable Public Law Children cases

- **Oxfordshire County Council v M & Ors [2025] EWFC 34 (B)**

Care proceedings, issued following concerns about mother's parenting. Ordered that child live with father, and for father to be permitted to relocate her to his home country.

## Private Law Children
