Care proceedings, issued after half-sibling suffered serious injuries caused by father.
- **T-D (Children: Specific Issue Order) [2024] EWCA Civ 793**
Appeal by mother from specific issue order giving father "over-riding parental responsibility" in three respects, including schooling.
- **Re AB (A Child: Diabetic Care) [2023] EWFC 149**
Mother accused of fabricated and induced illness by covert and chronic insulin maladministration.
