- **London Borough of Lambeth v M & Ors [2025] EWFC 55 (B)**
Care proceedings issued following a five year old child presenting at hospital intoxicated through consumption of the drug Topiramate.
- **Re CC (Fact Finding: Head Injury) [2024] EWFC 317 (B)**
Fact-finding in public law proceedings, concerning head injury to child.
- **Luton Borough Council v R & Ors [2024] EWFC 52**
Care proceedings concerning a 14 year old girl who had made allegations that she had been sexually abused by family members.
- **Re D F G and H (care proceedings) [2024] EWFC 30 (B)**
Care proceedings, issued following concerns over the level of care provided by parents.
- **Birmingham City Council v M & Ors [2023] EWHC 3312 (Fam)**
