Notable Public Law Children cases

- **Re B (A Child) (Post-Adoption Contact) [2019] EWCA Civ 29**

In November 2018, Justine appeared in the first case to reach the Court of Appeal following the implementation of s51A of the Adoption and Children Act 2002. She undertook the case Pro Bono, representing the interests of the prospective adopters and successfully defended the birth parents appeal against the court’s refusal to make an order for post-adoption contact.

- **Coventry City Council**

Justine appeared on behalf of Coventry City Council in the care proceedings arising out of the systematic torture and murder of Daniel Pelka. She was junior to John Vater QC during the fact-finding hearing before going on to represent the local authority alone at the disclosure hearing and final hearing.

Private Law Children

Justine has a strong private law children practice and has represented parents, children through their rule 16.4 court appointed guardians as well as other family members. She has experience in private law fact-finding hearings, including those concerning alleged sexual abuse, domestic violence and parental alienation.
