- **Oxfordshire County Council v M & Ors [2024] EWFC 261 (B)**
Care proceedings concerning one year-old child, issued due to concerns over emotional harm and neglect.
- **Wokingham Borough Council v The Mother & Ors [2024] EWFC 273 (B)**
Final hearing of care proceedings concerning two teenaged children, following findings that parents had assaulted them. Care orders made, with plan of long-term foster care.
- **The London Borough of Lambeth v RF & Ors [2024] EWFC 256 (B)**
Care proceedings in relation to two children, issued following concerns over parenting. Children placed with maternal grandmother under special guardianship order.
- **Wokingham Borough Council v The Mother & Ors [2023] EWFC 196**
Fact-finding in care proceedings concerning allegations that parents assaulted children.
- **Re M (adoption - notification of birth father) [2023] EWFC 17**
Adoption application in which court ordered that birth father be notified, but birth mother refused to reveal his name, and he could not be identified.

Acted for 3 teenage children in 12-day final hearing involving allegations of physical and emotional abuse, and managing complex family dynamics
- **Re H [2017-2018]**
